An 11-day Program subdivided into 5 separate courses provided by the Spiral Foundation at AOTA

As the USC/WPS* Sensory Integration and Praxis Tests (SIPT) certification program is being discontinued, the Spiral Foundation USA, an approved provider of Continuing Education by the American Occupational Therapy Association (AOTA), began to offer the "Program for Essential Competencies in Sensory Integration (PECSI)" since 2016. The certification PECSI Hong Kong is a 100 contact hour course series (10 AOTA Continuing Education Units, CEUs) designed to provide clinicians with a solid foundation of skills to understand, evaluate and treat SI difficulties by obtaining learning experience on SI theory, assessment, SIPT administration, assessment interpretation and SI intervention.
